International BBA Program is an innovative concept in education, which provides an opportunity and access to students for studies abroad. They complete the first two years of their foreign degree program at Christ University in Bangalore, India. Then, they proceed to complete the remaining years of their studies at the affiliated foreign university.

Visa

The responsibility of obtaining the visa rests with the student. Christ University will provide assistance in procurement of visa. The students must be ready to furnish proof that necessary finance is available for the expenses at the foreign university.

Eligibility

A pass in the PUC Board/CBSE/ISC or equivalent is the minimum eligibility to apply.

Fees

- Processing fees**

Kindly note that the processing fee should be paid along with the First year program fee during the time of admission.

All students transferring to Foreign University need to pay DD of Rs **130,000** as “Processing Fees” in favour of “Christ University.” (**Note:** Students transferring to Western Michigan University need to pay this amount in the following form: One DD for **Rs. 85000** in favour of “Christ University” and another DD for US \$ 1000 in favour of “Western Michigan University, USA”).

Bachelor Degree in Business Administration – BBA (2 + 1): 3 years (6 Semesters) degree course of which two years will be at Christ University and the remaining one year at IESEG School of Management.

The MSc degree program is open to students having completed IESEG BBA and a direct entry is given in the MSc degree programme.

Two semesters are dedicated to learning **Management in classroom** at IESEG School of Management. Students are also required to do a **one-semester internship** as a manager in France or abroad. Finally, all participants are required to complete a **Master's thesis or consulting project in France or abroad (1 semester)**.

Eligibility for Transfer to IESEG School of Management

You can transfer to IESEG School of Management by completing 4 semesters at Christ University with a minimum grade point average of 2.0(70%) out of 4(100%). An IELTS test (the International Language Testing System) is mandatory with a minimum score of 6.
