**2 YEARS IN CHRIST UNIVERSITY (BBA) + 1 OR 1.5 OR 2 YEARS IN A FOREIGN UNIVERSITY**

#### *TRANSFER OF STUDENTS TO FOREIGN UNIVERSITY IN 2015*

International BBA Programme is an innovative concept in education, which provides an opportunity and access to students for studies abroad. They complete the first two years of foreign degree programme at Christ University in Bangalore, India. Then, proceed to complete the remaining years of studies at the affiliated foreign university.

#### **Objectives of International BBA Programme**

- To provide quality education at reasonable cost
- To provide educational experience through international exposure
- To qualify students for world competition in the global employment market
- To increase student capacity to lead productive and responsible lives and also bring about open minded, tolerant and humanistic approach towards each other on the campuses and in the world community

#### **Degree Offered**

The degree is awarded by the foreign university on completion of the programme.

#### **Visa**

The responsibility of obtaining the visa rests with the student. Christ University will provide assistance in procurement of visa. The students must be ready to furnish proof that necessary finance is available for the expenses at the foreign university.

#### **Options Available for Transfer to Foreign Universities**

After completion of two years in Christ University, students can transfer their credits to partner foreign university for completion of the programme. In the foreign university the students may spend either 1 or 1.5 or 2 years. (1 to 2 years)

(2 Years BBA in Christ University + 1 Year in IESEG)

It is a member of the Catholic University of Lille and is legally authorized by the French Ministry of Higher Education and Research to provide tertiary academic qualifications. ### **Courses Offered**

**Bachelor Degree in Business Administration – BBA (2 + 1):** 3 years (6 Semesters) degree programme of which two years will be at Christ University and the remaining one year at IESEG School of Management.

### **Master of Science Programme**

**MSc:** 2 years (4 semesters) degree programme.

The MSc degree programme is open to students having completed IESEG BBA and a direct entry is given in the MSc degree programme. Two semesters are dedicated to learning Management in classroom at IESEG School of Management. Students are also required to do a one-semester internship as a manager in France or abroad. Finally, all participants are required to complete a Master's thesis or consulting project in France or abroad (1 semester). Students can enroll without work experience.

**MBA-**Students will require work experience (minimum 2-3 years)

### **Eligibility for Transfer to IESEG School of Management**

You can transfer to IESEG School of Management by completing 4 semesters at Christ University with a minimum grade point average of 2.0(70%) out of 4(100%). An IELTS test (the International Language Testing System) is mandatory with a minimum score of 6.

### **Tuition Fees and Accommodation Charges**

BBA Course: US \$ 11000 +US \$ 10500 approx (for 1 year)

MSc Course: US \$ 22000 +US \$ 21000 approx (for 2 years)

**Work while Study:** Foreign students are allowed to work 20 hrs per week once they have their resident permit.

**Work after BBA Study:** Students need sponsorship from the company to get work permit.

**Work after MSc Study:** Students will have a six month extension of visa after their MSc study to look for a job. Students need sponsorship from the company.

### **Work while study:**

Students can work for 20 hours per week on or off campus while studying. This pocket money can partially cover your living expenses.

### **Master Programme (1 Year)—optional**

Students can enroll without work experience. On completion of the Bachelor's programme, students can progress into the following Master's programmes at Sheffield Hallam University. **Duration:** 1.5 years

##### **Eligibility for Transfer to Griffith University**

You can transfer to Griffith University by successfully passing/completing 4 semesters at Christ University. An IELTS test is mandatory for an Australian Student Visa with a minimum score of 6.

##### **Tuition Fees (for 1.5 years)**

US \$ 27000 approx

##### **Living expenses (for 1.5 years)**

US \$25000 approx

The students can work for 40 hours per fortnight to cover the living expense cost (Minimum wages Act A\$ 15 per hour). Most of the students can recover the entire living expenses as they get approx A\$ 1200 per month.

##### **Work while Study:**

Students can work for 40 hours per fortnight on or off campus while studying. This pocket money can cover partial living expense.

**Post Study Work Visa:** to be eligible for the Post-study Work visa, students must have completed their studies in Australia while on student visa for Minimum 2.0 years (either take additional around 4 subjects i.e one extra semester for completion of undergraduate program or can enroll for Masters Program). Graduates who have completed a Bachelor Degree or Masters by course work degree in Australia will be eligible to apply for a post study work visa for 2.0 years. ##### **Masters Program:** 1 year (optional)

A successful completion of two years study at Christ University, Bachelor of Business Administration programme with a minimum Grade Point Average of 2.5 ( 75%) + TOEFL + SAT. The University will provide the Form I-20 from WMU and will make it available to the students for visa purposes.

### **Work While Study**

Students can work for 20 hours per week on campus while studying. This pocket money can cover partial living expense.

### **Tuition Fees & Living expenses (for 1.5 years)**

US \$ 50000 +US \$ 18000 approx

Note:

1. Students need to take summer classes to complete the course in around 1 ½ years
2. Students can recover part of the living expense by working on campus.

### **OPT (Optional Practical Training)**

Students can work for one year in the company after completion of BBA. The student can get regular salary.

### **Masters Program**

MBA-Work experience not required. The program is conducted in the evening. The course can be completed in 2-3 years while working.

### **Work while Study**

As a student you are legally permitted to work 20 hours a week during term time.
