
We conduct workshops and national level seminars on a regular basis to inculcate research culture among the teaching community and generate pertinent perspectives.

Welfare Paradigms and Social Sectors

Recent events in the world have pointed to an increasing probability of crises in several economies that have dabbled with neo-liberal policy orientations. In the meantime, the decision-making of the State in several national economies is directed towards balancing between regional and global orientations. In other words, the State and the civil society sense the need to introspect on their stand about social well being. Against this political economy backdrop, a new set of ideological debates in academic circles, i.e., in terms of the (in)stability of capitalism and the (non-)availability of effective alternative systems is ignited. Issues of welfare and those concerning the social sector also come to the forefront, inviting fresh contestations in the Social Sciences.

In a more specific sense, social and economic welfare policies and approaches have reached a new crossroad in the context of globalization and receding roles of the governments. The true nature of the real world problems is not encouraging the implementation of a perfectly competitive free market economy as they may fail to ensure good results. It is in this context that a new wave of voluntary, non-profit institutions have emerged atoning for the failures of the State and the inefficiency of the competitive market. They are more efficient and highly flexible when it comes to the distributive outcomes for the economy. The third sector institutions seem to be mature enough to assume the responsibility to build a more equitable, modern and sustainable society as they have developed a new perspective to guide the future development of our social and economic welfare system even as meeting the formidable challenges of risks grows in tandem with globalization.

The National Seminar on Welfare Paradigms and Social Sectors organised by the Department of Economics, Christ University, proposes as its core objective to track such debates in this domain of social science discourse.
